Since 1982, Wilkinson Center has used a holistic approach to address the problems causing, and caused by, generational poverty. Wilkinson Center is a leading poverty rescue and prevention organization that serves more than 12,000 individuals in Dallas County each year. Wilkinson Center helps those in need meet their challenges through a wide variety of programs and services - including access to the basic human necessities of food and emergency services, adult education, employment services, and 2 generation learning for mothers and pre-school children. A majority of the organization's clients are served at the agency's Buckner Boulevard locations in South Dallas - the Buckner Food Pantry, the Family Education Center, and the Pleasant Grove Campus of Eastfield College. In addition to these locations, clients may receive various services at affiliated locations across Dallas.

# EXECUTIVE SUMMARY

Wilkinson Center serves an area of Dallas that is incredibly diverse - demographically and economically. The organization's service area has concentrations of low-income families far greater than the State and National averages in addition to some of the most desirable neighborhoods in the City. Some living in this geography are in need of a variety of services in order to move towards self-sufficiency. The Wilkinson Center aims to improve the lives of those in need by offering classes and resources beneficial to those in need.

This report condenses information into a clear and concise snapshot of demographic and economic conditions in the 9 ZIP code area assigned to Wilkinson Center's food pantry by the North Texas Food Bank (NTFB). A variety of topic areas are described in context to this service area, including a look at food insecurity; the demand for adult education, ESL, and computer literacy courses; accessibility to public transportation; affordable housing; affordable healthcare; and income growth. The report aims to provide contextual information on these topics to help guide future strategies for serving those living in the 9 ZIP code service area.

Highlights of the report include:

- Roughly 16.8% of the population in the service area is at risk of food insecurity.
- Educational attainment in the 9-ZIP Code service area is far lower than County or State levels with more than 29% of the adult population lacking a high school diploma in 2013.
- Almost 30% of the population still lacks health insurance in 2013.
- Several Census Tracts in East Dallas, South Dallas, and Pleasant Grove experienced major decreases in overall poverty from 2008 to 2013 some dropping by almost 25%.



# INTRODUCTION

Wilkinson Center currently provides a wide range of services to its clients in East and Southeast Dallas. These services, ranging from food assistance to financial education classes, are designed to help those in need access basic necessities and develop plans to achieve economic stability. The primary service center, located at Towne Market Center on Buckner Boulevard in East Dallas, is able to easily serve many Wilkinson Center clients.

The Wilkinson Center uses an approach to poverty intervention that emphasizes clients' ability to establish control over their lives. Clients are provided a one-week supply of groceries per month, for up to six months, and many clients work with their case managers during this time to identify barriers to stability, make plans to overcome barriers, and track their progress toward self-sufficiency. However, senior citizens, clients with disabilities, and mothers with young children who are unable to access adequate childcare are not required to follow these steps. This approach to cultivate self-sufficiency is achieved through the coordination of case management, education, and referrals to other community resource providers.

This report documents the socioeconomic and demographic characteristics of clients accessing services through Wilkinson Center, and explores conditions in the service area assigned to the Buckner Food Pantry by the North Texas Food Bank (NTFB). In assessing this specific geographic area, various community indicators are explored to provide a snapshot of conditions within East and Southeast Dallas.

The service area assigned to The Wilkinson Center by the NTFB includes 9 ZIP codes, shown on the map at right. Any client receiving food assistance from the Buckner Food Pantry must live within this 9 ZIP code area. However, clients enrolled in other Wilkinson Center programs or classes are not required to live in these same areas. As such, some services are administered at a number of smaller locations across Dallas.


In addition to the socioeconomic and demographic characteristics of the local geography, this report collects and compiles lists of other community resources located within the service area and its immediate surroundings.




# FOOD ASSISTANCE CLIENTS


Wilkinson Center's Food Assistance Program has been at the core of the organization from the beginning and often serves as the first point of contact for many clients. In a given week the food pantry will supply more than 40,000 pounds of emergency food to individuals and families living in Dallas. The map on the opposite page shows a sample of existing Wilkinson Center clients who utilize the food pantry. While the numbers are relatively low in most Census Tracts, higher concentrations of food assistance clients are located along major thoroughfares within the 9-7IP code service area.

The vast majority of food assistance clients are unemployed (91%) and non-white minorities (89%). Black or African American clients make up 57% of the food assistance clients and another 26% are non-white, Hispanic individuals. Household composition of food pantry clients varies, with half of these clients belonging to single-women households (50%). Couples and singleman households make up 18% and 17% of this group respectively. Roughly 29% of households support children, with roughly 45% of children belonging to a single-parent household. Single-mother households are much more dominant than coupled or multigenerational parent/guardian households.




### CLIENTS BY EMPLOYMENT STATUS (n =2,184)





#### CHILDREN BY FAMILY COMPOSITION (n =1,070)




## ADULT EDUCATION CLIENTS

Wilkinson Center's Adult Education program has supported low-income residents for over a decade. Clients who take adult education classes through Wilkinson Center gain skills needed to achieve personal and financial self-sufficiency. The map on the opposite page shows concentrations of clients that utilize adult education services. Unlike clients of the food assistance program, adult education clients are not restricted to the 9-ZIP code service area. Clients of these services can, and do, come from other parts of the city. However, many clients do live within the Wilkinson Center's defined service area. The vast majority of students attend classes provided at Eastfield College's Pleasant Grove campus.


Adult education students are primarily of Hispanic origin (76%) and take classes geared toward Spanish-language speakers - English as a Second Language (ESL), Computer Literacy and Skills (CLS), and General Educational Development (GED). As with food assistance clients, a majority of adult education clients are part of a singlemother household - owing to the overwhelming number of women who attend adult education courses (85% of adult education clients). Additionally, while coursez are offered at a number of campuses, an overwhelming majority of clients attend class at Eastfield College (63%), with about 30% visiting the Family Education Center. Student attendance at other locations affiliated with the Wilkinson Center is substantially lower.

STUDENTS BY PROGRAM (n = 627)




# WORKING POOR FAMILIES

Dallas County, and the City of Dallas in particular, has a poverty crisis. An extremely high number of families and children are impoverished or low income, despite relatively low unemployment (5.9 percent for Dallas County in August 2014, compared to 5.5 percent for Texas and 6.1 percent nationally).<sup>1</sup> A particularly telling statistic is that 27 percent of families in poverty in the City of Dallas had a householder that was employed full-time in 2013 compared to the rate for families in poverty nationally (11.3 percent) — demonstrating that employment is not sufficient to keep families out of poverty.<sup>2</sup> In the City of Dallas, 40 percent of families are low-income working families with children, the highest proportion among the 50 most populous U.S. cities.<sup>3</sup> In Willkinson Center's service area, the percentage of children living in low-income households is a staggering 72 percent.<sup>4</sup>

The living wage scenarios on the opposite page draw attention to the inadequacy of the official poverty measure to realistically account for who is "poor" and what it takes to make ends meet in Dallas County, with each of these families needing to earn a minimum of 2.5 times the poverty threshold in order to be self-sufficient. Also highlighted is that single-income households, the vast majority of which are headed by women, face greater obstacles than two-parent families attaining self-sufficiency. This data points to the need for low-income families to rely on public assistance, familial assistance, or other support in order to make ends meet, severely constrained in their choices and opportunities. Families may be forced to skimp on certain expenditures—such as food or health care—in order to pay for others, such as housing.<sup>5</sup>

## PERCENTAGE OF FAMILIES THAT ARE LOW-INCOME 6





## LIVING WAGES BY FAMILY TYPE IN DALLAS-PLANO-IRVING 10

The graphic below shows what different family types need to earn in order to meet all of their monthly expenses — housing, food, childcare, medical insurance, transportation, federal taxes, and other necessities — without any savings in the Dallas-Plano-Irving Metropolitan Division. The majority of workers do not earn enough to support their families on wages or salaries alone. The current federal (and Texas state) minimum wage is \$7.25 an hour; a full-time minimum wage employee earns only \$15,080 annually - far short of the income needed to support most families.<sup>11</sup>



# LOW-INCOME WORKFORCE


The Dallas - Fort Worth Metroplex offers access to a diverse set of job opportunities in a wide range of industries. However, data collected by the U.S. Census Bureau's Longitudinal Employer-Household Dynamics program, which allows researchers to get a more fine-grained look at the types of jobs held within different geographic units, offers a different look at the landscape of jobs in Dallas County.<sup>12</sup>

The map on the next page compares jobs with earnings of \$1,250 a month or less to the total range of available jobs in Dallas Count. An income of \$1,250 a month translates to roughly \$15,000 a year. Almost 20% of the jobs available in Dallas County earned less than this in 2012. However, while these jobs are available across the county, most jobs are located in the north with a much sparser concentration of jobs in the southern half of Dallas County.


Of Dallas County's roughly 1.3 million jobs, almost 20% earn less than \$15,000 a year. 63% of these low-paying jobs are primarily concentrated in four main industries - retail trade, waste management, health care, and accommodation & food services. Those receiving, and in need of, services are more likely to work in these four industries than others. For Retail Trade and Accommodation & Food Service workers, in particular, work schedules may make it more challenging to access needed services or to find adequate childcare.



GEOGRAPHY OF JOBS IN DALLAS COUNTY 14








# SERVICE AREA DEMOGRAPHICS

Wilkinson Center currently serves a large portion of East and Southeast Dallas - from the neighborhoods along Central Expressway north of downtown to the far reaches of Pleasant Grove. Demographic characteristics and trends across this geography area are not uniform - neighborhoods and residents living near White Rock Lake experience much different conditions than those in the South Dallas / Fair Park neighborhood.


The map on the opposite page shows the percentage of families in the service area in poverty as of 2013. Much of the area served by Wilkinson Center has relatively high concentrations of families in poverty. However, there are clearly portions of the service area less affected by poverty than others. Much of the area west of White Rock Lake and east of Central Expressway have fewer than 6% of families living in poverty, while much of Pleasant Grove and neighborhoods running along Scyene Road see much higher rates of poverty.

The same areas that have a relatively small portion of families living in poverty to the west of White Rock Lake have seen a considerable increase in the percentage of those living in poverty from 2008 to 2013. During the same period of time, Vickery Meadow, an area just across Northwest Highway and known for having a large population living in poverty, has shown a major decrease in poverty. When exploring the median household income at the Census tract level, Dallas' frequently discussed North-South divide is unmistakable - as you move north from I-20 median household income gradually increases from less than \$32,000 a year to more than \$81,000 year in neighborhoods in the northern reaches of the service area.<sup>16</sup>


This diversity within the service area is evident regardless of the data. This section of the report provides a number of maps and data visualizations of community indicators to aid Wilkinson Center staff and others to further understand and serve the geography.

Median Household Income, 2013 (USD) <sup>18</sup>




Potential Food-Insecure Individuals (per sq. mi.) <sup>19</sup>


## DEMAND FOR FOOD ASSISTANCE

In 2012, 14.5% of US households had problems accessing meals at some point in the year. This population, defined largely by high rates of unemployment and poverty, must spend upwards of 30% of their income to purchase food and eat nutritious meals.<sup>2021</sup> Food insecurity is not defined as a permanent situation, but may affect a food insecure household for at least seven months a year.<sup>22</sup> Regional variations in food insecurity indicate that the southern US faces greater challenges in maintaining food security than the rest of the country, with Texas and Dallas County experiencing food insecurity rates much greater than the national average (18.3% and 20%, respectively). Dallas County is ranked 6th nationally in the number of food insecure individuals with an estimated 476,540 food insecure residents, and \$213,512,000 is needed annually to meet their needs.<sup>23</sup>



Data from the 2013 BLS Consumer Expenditure Survey was used to explore the financial burden of accessing food for at risk populations.<sup>30</sup> While households and individuals with higher median household incomes spend more on food in a year, lower median household income groups spend a far greater percentage of their annual income on providing for their basic needs. In the most extreme cases, more than 30% of a household's income can be attributed to food expenditures. In areas with high burdens of food expenses, it is also likely that housing and transportation burdens could have an impact on a household's ability to be food secure. Food insecure individuals may have difficulty in accessing nutritious foods for a variety of reasons; however, existing research focuses on financial and environmental burdens related to decreased nutritious food access.<sup>25</sup> Organizations such as the United States Department of Agriculture (USDA) and Feeding America conduct research on food insecurity at the national, state, and county levels, however, sub-county level research is largely unexplored in the professional and academic literature.<sup>26 27 28</sup> This body of research on food insecure populations can be used to guide sub-county level estimates of food insecurity. Unemployment and poverty were the strongest predictors of food insecurity in a Feeding America report, showing a 0.51% and 0.19% increase in food insecurity for every 1% increase in each, respectively.<sup>29</sup> The map on the opposite page displays sub-county estimates of food insecurity derived from a simple linear model using these two variables.






Adults With No High School Diploma (per sq. mi) <sup>32</sup>

## DEMAND FOR ADULT EDUCATION


The most recent National Assessment of Adult Literacy (NAAL) was conducted by the National Center for Education Statistics (NCES) in 2003. At the time, 21% of adults in Dallas County had below basic prose skills, compared state and national levels of 19% and 14%, respectively.<sup>33</sup> During the previous NAAL, in 1992, only 16% of adults in Dallas County had below basic prose skills. This decrease in adult literacy is an alarming trend. However, new data on adult literacy has not yet been collected at the same scale by NCES or others.

In the 2003, adult literacy was linked to a number of social, economic, and educational indicators. Individuals with low income and low educational attainment were much more likely to rank in the lowest level of literacy. For instance, it was estimated that 55% of illiterate adults did not obtain a high school diploma and 56% of illiterate adults were unemployed.<sup>35</sup> Additionally, Black and Hispanic populations were more likely to experience lower rates of literacy than other races or ethnicities. Currently, estimates for adult literacy rates across Dallas County are unknown. However, various indicators connected to literacy paint a grim picture – suggesting that populations at risk of illiteracy continue to persist across the county.<sup>36</sup>






Adding to the issue of adult illiteracy, the rise of digital technology has reshaped modern life in almost every way possible. Unfortunately, these dramatic changes have also created an invisible divide between those who can and do regularly use technology and those who do not. Familiarity with computers, Internet-related services, and specific computer software is increasingly a requirement for employment, even for low-skilled jobs. In 2013, some 94% of workers in the country relied on computers and the Internet to perform basic tasks.<sup>37</sup> These rapid changes have been seen as a driving factor in rising wage inequality between low- and high-skilled workers; favoring highly educated workers more likely to understand, employ, and adjust to technological changes in the workplace.<sup>38</sup>




BROADBAND ACCES AT HOME BY EDUCATIONAL ATTAINMENT (%) <sup>39</sup>

However, one's ability to use technology is only a part of the story. Access to and adoption of the Internet is becoming an ever-increasing problem. According to the Pew Research Center's Internet Project, Internet use has steadily risen over the last 20 years and the percentage of Americans not using the Internet is only 15%, an all-time low.<sup>40</sup> As with computer use, a divide exists between those who do and do not have access to the Internet. While use of the Internet has been shown to empower individuals in a many ways it can also be used to grow technical competence and information literacy. National surveys have suggested that regular access to technology is required, ideally through home access.41 While the use of mobile devices has expanded access to the Internet, particularly within low-income and minority communities, home Internet connections remain the most frequent way to connect.42



## DEMAND FOR ESL EDUCATION


In 2013, 11% of Dallas County residents spoke English less than "very well" and 9.3%, or approximately 240,000, adults over the age of 18 did not speak English well or at all.<sup>44</sup> Using this variable as the strongest predictor for ESL service need, [bc] developed the Weighted ESL Need Index in partnership with Literacy Instruction for Texas (LIFT).<sup>45</sup> In addition to the population that speaks English less than very well, a wide range of indicator variables were used to predict need for ESL services at the Census tract level. That is, tracts that score highly in the Need Index are likely to have populations more in need of ESL courses than those in lower scoring tracts.

Variables used to assess a tract's need for ESL service include: percent of the population of Hispanic origin, the percent of the population foreign born, the percent of adults below poverty, the percent of adults with less than a high school education, and the unemployment rate. Overall, many parts of The Wilkinson Center's service area are estimated to have a high need for ESL related services. In fact, with over 76% of existing adult education clients identified as Hispanic the need for ESL services in these parts of the city is evident. Courses geared towards Spanish language speakers represented roughly 60% of adult education attendance in 2014. Established computer literacy courses offered by Wilkinson Center can go great lengths to helping low-income, non-English speakers gain technological familiarity and skill necessary for many jobs in the modern economy. As discussed in the previous section, gaps in Internet access exist based on one's education level. Similarly, only 30% of Spanish-speaking adults have broadband access at home, compared to 70% of all adults surveyed.

As can be seen in the map on the opposite page, several areas within Wilkinson Center's service area show a greater need for ESL education than much of the rest of the city. Tiny pockets in ZIP codes 75204 and 75206, corresponding with neighborhoods such as Fitzhugh/Capital and Henderson, stand out from the surrounding areas. But much of the Pleasant Grove, Pemberton Hill, and Parkdale neighborhoods also score highly on the Weighted ESL Need Index - corresponding with areas Wilkinson Center already draws adult education clients from.




Single Mother Households, As Percent of Total Households <sup>47</sup>

# SINGLE-MOTHER HOUSEHOLDS


Poverty affects women at far greater rates than men, and single mothers are much more likely to live in poverty than their married counterparts.<sup>48</sup> While there are variations in the rate of single-mother poverty between racial and ethnic groups, the major divide is between those married and unmarried mothers. This trend, shown at the national level in the chart below, helps highlight the potential for high concentrations of poverty in areas with high concentrations of single mother households. Wilkinson Center already serves a large client base of single-mothers (50% of food pantry clients).

However, while single mother households are typically more than two times as likely to be in poverty as married couple households, single parent households are on the rise across the country.<sup>49</sup> Newer trends in marriage and family planning may offset this trend over the coming decades. At present this does not appear to be the case. Today, children from single mother households are more likely to drop out of school, to be arrested, be unemployed, and less likely to go to college than children from married parent households.<sup>50</sup> Policies and programs that help single mothers overcome their day-to-day challenges are an important step in improving the possible outcomes of their children.

Large portions of Wilkinson Center's service area have high concentrations of single-mother households - much of the area to the west of US 175 at Loop 12 in southeast Dallas; east of Buckner Blvd. near Scyene Rd. in east Dallas extending along Buckner north of I-30.



## POVERTY RATES OF MOTHERS BY RACE, ETHNICITY, & MARITAL STATUS (U.S. 2013) <sup>51</sup>




Population without Health Insurance (2013) 52,53


# DEMAND FOR AFFORDABLE HEALTHCARE

Health care in America is expensive and often difficult to access. The cost, accessibility and availability of health resources disproportionately impact the poor and the uninsured. In 2013, roughly 30% of uninsured adults did not seek care due to the high cost of health services.<sup>54</sup> In turn, the poor are disproportionately uninsured. 27% of the uninsured in America were below the federal poverty level and 58% were below 200% of the federal poverty level in 2013.<sup>55</sup> Not only do the poor have greater difficulty accessing healthcare, but receiving treatment can also perpetuate or exacerbate their poverty. While the Affordable Care Act is projected to positively impact access and cost for many uninsured low-income Americans, these impacts will have lessened impact on Texas, which has chosen not to expand Medicaid. Data reflecting changes in insurance coverage since the inception of the ACA are not yet available at the local level - however broader trends at the state and national level suggest positive changes are underway.

The related burdens of high healthcare costs and negative health conditions are particularly problematic in Dallas County, where nearly one in five people suffer from poverty. Among families, the poverty rate in Dallas is greater than that of both Texas and the United States, and is nearly triple that of Collin County. Compounding the increased susceptibility to chronic health conditions facing those in poverty, Texas and Dallas in particular have inordinately low rates of health insurance coverage. Texas has the lowest rate of insurance coverage among all U.S. states, and the 9 ZIP codes served by Wilkinson Center is worse yet with roughly 30% of the population not covered by health insurance in 2013.<sup>56</sup>



## POPULATION THAT ARE UNINSURED (%) 57




Renter Occupied Households, as Percent of Occupied Households 58


# DEMAND FOR AFFORDABLE HOUSING

Housing and transportation related costs - car payments, fuel, rent, and mortgage payments - are some of the most costly expenses a household must pay. Typically, housing cost burdens are greater for those who rent their homes and those who make less than \$50,000 a year in household income.<sup>59</sup> Much of Wilkinson Center's service area exhibits high rates of rental units and poverty - suggesting that housing costs are a greater burden for populations living in these communities. Unfortunately, the current state of the Dallas-Fort Worth housing market makes it much more difficult for lower socioeconomic households to purchase affordable homes in affordable neighborhoods. The existing stock of affordably priced units does not currently match the demand for such units.

The highest concentrations of renter occupied households in Wilkinson Center's service area are in the neighborhoods of Old East Dallas - Junius Heights, Munger Place, Mount Auburn - and parts of South Dallas. Renteroccupied units are less prevalent across Census tracts in Pleasant Grove, although lower-income owner-occupied units are concentrated in many parts of the service area. At the Census tract level, there are large disparities in rates of home ownership across the service area. However, it does not appear that areas with higher concentrations of owner-occupied units strongly align with areas of concentrated poverty in the area. Many homes in parts of Pleasant Grove, in the south of the service area, are valued below \$100,000 - revealing a major difference between many of the Census tracts in the northern part of the service area with median home values greater than \$150,000.

# TRANSIT ACCESS

In addition to housing, transportation related costs are a major part of most households' monthly expenses. As a result of this, lower income households are much more reliant on public transportation and other alternative modes of transportation than those with higher incomes. Dallas, overall, is well served by public transportation. Dallas Area Rapid Transportation (DART) operates the largest light rail network in the United States, and a comprehensive bus network serving a major part of the Dallas - Fort Worth Metroplex. However, access to bus and rail routes is not uniform across the region - many areas have limited service or no service available from DART or other regional transit agencies.

Fortunately, much of Wilkinson Center's service area is within a quarter of a mile of a DART bus stop or light rail station. While 9 DART Rail stations are in the service area, the vast majority is only served by DART's bus system. Lower-income households that are more likely to rely on public transportation to travel to work, grocery stores, or doctors offices may face long commutes to access necessary services if they do not have access to a personal vehicle. However, access to DART's extensive bus route does enable those who rely on public transportation to access DART Rail lines to travel across the region served by DART, The T (Tarrant County), and DCTA (Denton County).

However, access to DART services does not necessarily enable low-income residents of the service area to access jobs. As low income populations migrate further from the urban core, due to revitalized growth in Downtown Dallas and Uptown, in particular, lower income residents may see themselves forced further away from areas and jobs well served by transit. A 2011 study by the Brookings Institute found that low-income residents reliant on transit in metropolitan areas can only access 30 percent of jobs within 90 minutes or less via transit.<sup>62</sup> As demonstrated earlier in this report, many jobs within Dallas County lie to the north and west of Wilkinson Center's service area.

# OTHER RESOURCES

A number of different types of facilities exist within Wilkinson Center's service area. Schools, childcare facilities, and other social service providers all occupy space within the landscape. The following pages show the locations of existing facilities within and surrounding the 9 ZIP codes explored in this report. For each map, Appendix 1 lists the facilities that fall *within* Wilkinson Center's service area

#### SCHOOLS 63


The Wilkinson Center serves a large geographic area, covering a major portion of eastern Dallas. 61 Dallas Independent School District campuses are within the service area - 44 elementary schools, 8 middle schools, 6 high schools, and 3 magnet or alternative schools. Additionally, roughly 17 charter schools are located in this same region.


### SOCIAL SERVICE PROVIDERS

Comprehensive listings of nonprofit organizations and/or social service providers are difficult to come by. Using Guidestar, [bc] staff compiled a list of nonprofit social service providers located in the 9 ZIP codes served by The Wilkinson Center.<sup>64</sup> Unfortunately, due the large number of social service providers in surrounding ZIP codes it was not possible to compile and map lists for the surrounding areas. Additionally, this lists only identifies nonprofit social service providers that serve clients in the same geography.


#### CHILDCARE CENTERS

The State of Texas' Department of Family and Protective Services maintains a large database of all childcare centers operating within the state.<sup>65</sup> Childcare centers fit into two primary categories: Listed Family Homes and Licensed, Registered Facilities. Listed Family Homes are based in the primary caregivers home and serve fewer than 12 children in a 24-hour period. Licensed, Registered Facilities serve 13 or more children aged 2 months to 13 years. These facilities serve clients for no more than 24 hours a day. However, a small number of facilities are permitted to serve clients 24 hours a day and are primarily based in the residence of the primary caregiver.
